

The Commissioners received a letter of resignation from David R. Shoupe as of March, 20, 2015 from the Powell County Road Department, District 2-Ovando.


Brian Bender presented a termination agreement with the Department of Natural Resources and Conservation for Grant Agreement #RITP-12-0055.
