ARROWSTONE PARK BOARD TRAILS SUBCOMMITTEE

The Trails Sub-Committee met in regular session on Wednesday, December 19, 2018 at 10:30a.m. in the Hospital Board Room.

Agenda Item #1 - Call to Order

President Duncan called the meeting to order at 10:30am and with six members present, a quorum was established.

Agenda Item #2 - Approval of Minutes

Member Johnson motioned to approve the meeting notes from last meeting, November 26, with Member Rase seconding the motion. The Members approved the minutes by a vote of 6-0.

Agenda Item #3- Old Yellowstone Trail

Mr. Hamming discussed the objective of the meeting to provide guidance to Great West Engineering as to the County's preferences for trail improvements. The Committee discussed the various options and recommended placement of various features and Mr. Hamming will present the choices at the Parks Board meeting and follow up with GWE.

Member Swant suggested the Committee promote the plans for the trail in the Silver State Post. Member Fischer will draft up some bullet points to submit to the paper as well as provide the figure with the concept for the trail location. This will help publicize the temporary closure of the trail to the local community. Member Swant also raised the topic that the trail should include signage that informs the public that hunting/shooting is not permitted from the trail property.

Agenda Item #4 - RTP Grant/Johnson Creek

Mr. Hamming gave an overview of the RTP grant administered by the FWP that is accepting applications through January 2019. The Committee discussed different ideas for Johnson Creek and corridors that could be coordinated with the City to have a joint application that will enhance Johnson Creek as well as Jaycee Park. Mr. Hamming mentioned that the City is spearheading an effort to form a Committee focused on parks/trails efforts for Cottonwood Creek and the Committee discussed

representation as well as ensuring that the City and County collaborate. Mr. Hamming will keep the Committee informed.

Member Swant discussed the historic park previously located near the golf course. Mr. Hamming will do a little research regarding the old Deer Park.
